# Regions 1 & 2 LHRC Consolidation

- Currently in the final process of collapsing 22 LHRCs
- Ten (10) LHRCs will now serve Region 1 and 2.
- Four (4) of the ten (10) LHRCs are facility-based LHRCs, and six (6) of the LHRCs are community-based.
