Commodity: To provide Laboratory Reagents, Instrumentation and Services

This Supplemental Agreement is entered into pursuant to the provision of the basic contract.

Description of Modification:

This contract shall be renewed for a five-year period beginning July 1, 2012 and expiring June 30, 2017. This will leave two one-year renewals remaining on the contract, The five year renewal is based on the following conditions:

All five DBHDS labs will have their present Beckman Coulter HmX Hematology Analyzers replaced with the following remanufactured Hematology Analyzers:

Hiram Davis Medical Center (HDMC) – LH500
Eastern State Hospital (ESH) – LH500
Western State Hospital (WSH) – LH500
Central Virginia Training Center (CVTC) – LH500
Southwestern Virginia Mental Health Institute (SWVMHI) – HmX

The cost for the remanufactured equipment will be as follows:

Since four of the five labs' test numbers, as projected in the original contract, have dropped since the beginning of the original contract, the above cost are reflective of the cost adjustment made to the fees above for the drop in test numbers..

The delivery of the remanufactured equipment shall be as follows:

HDMC	Week of August 13 or weeks of September 10, 17. Or 24, 2012
ESH	Between August and Mid-September 2012
WSH	By July 1, 2012
CVTC	September 2012
SWVMHI	Between August and September 2012.

The remanufactured equipment includes a one year warranty and four additional years of standard business hours (M-F, 8AM-5PM) service coverage.

Except for the changes provided herein, all other terms and conditions of this contract remain unchanged and in full force and effect.
