Your contract with NRI for Behavioral Healthcare Performance Measurement System services for ORYX reporting to The Joint Commission for the hospitals listed in contract #720C-04155-0SROO will be **auto-renewed** on March 1, 2012 as specified in the contract terms. The contract period will be March 1, 2012 – February 28, 2013 and the **new fee is \$7160 per facility** for this contract period.

The Joint Commission has released its fee schedule for calendar 2012. There has been no change in the retransmission fee. As stated in the NRI contract, the retransmission fees are the responsibility of the provider when it elects to have historical data (previously closed quarters) transmitted to The Joint Commission.

- The HBIPS core measure set retransmission fee is \$180 per quarter per facility
- The non-core measure set retransmission fee is \$270 per quarter per facility


