Report of the Regional Advocate:

- Deb reported on 2 human rights trainings conducted; training being scheduled in August with Heritage House for ID providers to include Prince William County providers
- Deb provided an update on the statewide web-based reporting system under development
- Deb provided information regarding anticipated changes in LHRC currently under consideration by the SHRC as outlined in a memo to LHRC members dated June 21, 2010
- Deb provided an update on a memo released by the State regarding Crisis Wave, a behavioral management technique used by some providers where restraints termed "police tactics" are employed with an individual's arms being held behind one's back. The CW training has been revised with removal of "police tactic" restraints as an intervention tool.

Presentation: TODAYS Youth Services. Meghan Melvin and Michael Murphy presented information about therapeutic day treatment and intensive in-home services for youth provided in Richmond (5 years) and Petersburg (1½ years). A new office is opening in Ashland with services to clients residing in Caroline County. A request was made to seek affiliation with the FALHRC. There was discussion if the current affiliation in Henrico County might meet the 50-mile radius standard. While Deb is verifying the necessity for affiliation in our region, a Motion to provide temporary affiliation of TODAYS Youth Services with FALHRC was made by Lynn DelaMer, seconded by Nancy Sorrentino. Motion passed.

Old Business:

Update on the status of Blue Ridge Services affiliation fees – Karen reported that she talked with Kelly Murphy and was informed that the check had been mailed to the previous address of Family Preservation Services, fiscal agent for FALHRC, on April 23rd. Follow-up to verify receipt.

New Business:

- Potential Committee members a minimum of 5 members is required; with terms expiring of 2 members, the committee needs to recruit 2 new members. Grace Marshall submitted an application. Deb Lochart explained that, according to the Regulations, it is the responsibility of affiliates to maintain proper LHRC membership, and encouraged them to identify potential members, especially clients and/or family members of clients receiving services.
- Affiliate binders and contents Karen distributed notebooks with annual expectations, calendar
 of meetings and report due dates, and reporting forms (also provided on CD) to each affiliate;
 she notified affiliates that the annual fee will increase to \$150 per calendar year with payment
 due on January 1, 2011. A few revisions were noted; Karen will make suggested changes.
- Affiliation Agreement Nancy explained reasons for revisions on affiliation agreement to include a designated secondary liaison; new agreements for fiscal year (July 1 June 30) were signed by

- each attending affiliate and FALHRC chair Debe Fults; signed copies of agreement were provided to each affiliate
- Reports and Sample Report Forms Nancy explained revisions on quarterly and annual reporting forms; she provided an example of information to include on reports
- Purpose of the LHRC Deb Lochart gave an overview of the history of LHRC formation and affirmed the major purpose of LHRCs it for client protection
- Suggestions for types of trainings/information that affiliates might find beneficial for future meetings – there was group consensus to provide training on behavioral intervention techniques for providers, staff and client family members as it relates to human rights regulations; potential training sites were suggested – Salem Fields Community Center and Fairview Center on Route 2
- Purchase of a laptop for FALHRC business Discussion included the need for a laptop to remain
 the property of the FALHRC to streamline committee business including agendas, minutes, affiliate
 reports, etc. with a unique email address. A motion was made to purchase a laptop (and printer if
 determined necessary) by Tricia of Heritage House, seconded by Frank of NCG, and passed.
 Karen will research equipment and prices.
