The CCSB is working with the school system to determine a location for the program. Upon classroom assignment, a licensing site visit can commence. CCSB is seeking continued 90 day temporary affiliation. The motion to grant the 90 day temporary affiliation was approved.
- <u>Virginia Beach DHS</u> Licensing has not done the on site visit as of yet. Request for continued 90 day temporary affiliation for Jail Case Management Services & Outpatient Services was approved.
- <u>Burke Family Care</u>- Request for a permanent affiliation of 352 Agecroft Court. A permanent affiliation of 352 Agecroft Court was approved.

• <u>Eastern Shore CSB</u> requested to add a 17<sup>th</sup> rule to the ID Residential program rules and guidelines. The request to approve the addition of rule 17 was approved.

## Closed Session (VA Code 2.2-2711A)

The committee went into closed session according to section 2.23711A of the Virginia Code for the purpose of reviewing abuse, complaints, serious injuries, deaths and behavior plans for the following providers: Hope House, CAI, Eastern Shore CSB, and Virginia Beach Department of Health Services.

The committee came out of closed session into open session each committee member certified that the only thing discussed in closed session was the above noted programs. The committee recommended that VB DHS approved the behavior plan for Mr. B with quarterly updates.

The committee voted to go back in to closed session according to section 2.23711A for the purpose of reviewing abuse, complaints, serious injuries, deaths and behavior plans Burke Family Care.

The committee moved out of closed session and certified the only thing discussed was information related to Burke Family Care. Committee voted to recommend that Burke develop a behavior plan for Mr. W to address his phoning the police and EMS in non-emergency situations.

The committee voted to go back into closed session again according to section 2.23711A for the purpose of reviewing the serious injuries, abuse complaints for Chesapeake CSB. Committee voted to come out of closed session and certified that the only thing discussed were the serious injury and abuse complaints there were no recommendations.

Meeting adjourned.

Committee went back into closed session to review information related to the hearing April19th, 2010 for VBDHS.
