### **ADVOCATE REPORT AND TRAINING**

OHR Return to Field Operations Transition Plan began on April 1, 2021. OHR staff plans to resume onsite AIM24 visits, Independent and Joint Investigations, New Provider-Waiver Validation, and Facility Look Behinds.

### **OLD BUSINESS:**

Advocate will follow up with DePaul Community Resources on the following recommendations from the January 2021 meeting.

- Provide a phone log for all terminated calls and the reason for ending the call.
- Once staff determines a call is from a peer or professional, they will remove themselves from the call to provide the individual privacy.
- Provider will operationalize a criterion for staff to remain on the landline.

All matters were approved by a subcommittee and will be reviewed when there is a quorum at the next meetings.

### **NEW BUSINESS**

- Wall Residences reviewed one annual restrictive plan involving a lock on the half kitchen door.
- Blue Ridge Residential Services reviewed one restriction plan involving a refrigerator lock.
- Horizon Behavioral Healthcare reviewed a Next Friend.

### **CLOSED SESSION**

Upon a motion made by John Shepherd and seconded by Bruce Ellsworth, the committee entered closed session pursuant to Virginia Code §2.2-3711, a.15 and §2.2-37.05.5 for the purpose of discussion of treatment plans.

- Based on discussion of the need for the restrictive plan, it was recommended to approve continuation of the Restrictive Plan for Wall Residences with annual updates.
- Based on discussion of the need for the restrictive plan, it was recommended to approve continuation of the Restrictive Plan for Blue Ridge Residential with the following recommendations: This restriction was approved with the following recommendations:
  - Correct the spelling of Dysphagia

- Include the purpose of the restriction on the doctor's order; stating if the refrigerator was not locked the individual would get in the refrigerator and eat unsafe food.
- Based on discussion of the need for the Next Friend, it was recommended to approve the Next Friend for Horizon Behavioral Healthcare with no recommendations.
