1. **Call to Order**

The Local Human Rights Committee meeting was called to order at 10:45 a.m. with Charles Lounderman, Chair presiding, for the purpose of hearing business as presented on the agenda and such other transactions or matters that may be presented to the Committee.

2. **Agenda**

The March 20, 2008 and April 17, 2008 Agenda was reviewed.

Action: Motion was made by Ms. Bristow and properly seconded by Mr. McMahon that the LHRC approve the March 20, 2008 and April 17, 2008 Agenda as written. The motion passed unanimously.

3. **Minutes**

Minutes of the February 2008 LHRC meeting were reviewed.

Action: Motion was made by Ms. Bristow and properly seconded by Mr. McMahon that the LHRC approve the February 17, 2008 minutes as written. The motion passed unanimously.

4. **Hospital Directors' Reports**

Mr. Favret presented the February and March 2008 Disposition of the Abuse/Neglect Investigations Report ; Facility Monthly Report and the Formal

and Informal Complaints Report (see April 17, 2008, LHRC packet).

In reference to the Seclusion/Restraint Review of the monthly report, Mr. Favret clarified that safety restraints are medically necessitated under Doctor's orders.

He shared with the committee that the reason ESH residents are not being discharged is mainly due to not having appropriate housing. In addition, housing needs to be provided for the population that does not need to be at Eastern State Hospital.

Action: In support of this discharge/housing issue, LHRC Members will consider drafting a letter and forwarding it to the proper authorities. The committee members present accepted the Hospital Directors' Report for March 2008.

9. Attendance Letter/ Consumer Position -

Ms. Mitchell reported that the attendance letter regarding the consumer position has been sent to the SHRC to be presented at the April 18, 2008 meeting for approval. She has received an application from the community for membership on the ESH LHRC and will contact the applicant and set up a time to be interviewed at the May 15, 2008 meeting. Ms. Mitchell has also made the leadership committee aware that the LHRC was interested in another resident from the hospital to serve on the committee. Currently, she has not gotten a response.

10. ECT Hearing – S.A.

The motion was made by Ms. Schweiger properly seconded by Ms. Bristow, and passed for the LHRC to go into executive session pursuant to Virginia Code 2.2-3711(A) 4 for the protection of the privacy of individuals in personal matters not related to public business, namely for the purpose of hearing of authorized representatives, hearing of behavior modifications and/or conducting a hearing pursuant to the regulations. **Refer to Executive Session Minutes**

Motion was made by Ms. Schweiger and properly seconded by McMahon and passed that we go into open session. The LHRC unanimously

certified that, to the best of each member's knowledge, only private business matters lawfully exempted from statutory open meeting requirements and only private business matters identified in the motion to convene the executive session were discussed in the executive session.
