#### Presentation:

 This month the focus is on Choking and the Individual with IDD. Numerous cases of deadly choking events have come onto the DBHDS Mortality Review Committees (MRC) case load. There has been a spike in choking events within the community involving individuals with IDD. We will be reviewing how to handle emergency choking situations, how to dislodge an obstruction from the throat, when to call 911 for help and start CPR.
