This newsletter will provide updates on the DBHDS CONNECT licensing system and offers tips for using the CONNECT Provider Web Portal.

New Enhancements to CONNECT Provider Portal

- ❖ **Manage Background Check Contacts** has new functionality that only allows providers to assign one Background Contact per Contact ID. If your agency previously used multiple Contact IDs for a single contact to differentiate eligibility letters by location or by service, you will need to designate a separate person for each Contact ID. The TCN Number and Org Number now displays for each individual on the Background Check Status page for providers to easily track the status of fingerprints submitted through Fieldprint and view background check results.
