## Medication Assisted Treatment in Virginia



## What is Medication Assisted Treatment (MAT)?

- MAT is the use of medications for treatment of opioid use disorder (OUD) or alcohol use disorder in combination with counseling and behavioral therapies to provide a "whole-patient" approach to the treatment of substance use disorders, and can help some people to sustain recovery.
- For opioid use disorder, MAT, specifically buprenorphine and methadone, has the highest efficacy at
  preventing overdose death as compared to all other treatments, including naltrexone, counseling, and
  residential treatment.
- MAT is not a cure, it is a stabilizer by decreasing cravings, withdrawal symptoms and relapse.
- Increased risk of serious side effects when combining these MAT drugs with benzodiazepines often prescribed to treat anxiety, insomnia, or other conditions.
- The three classes of drugs approved by the FDA for the treatment of opioid dependence are buprenorphine products (i.e. Subutex ®, Sublocade ®) and buprenorphine/naloxone (ie. Suboxone ®), Mu-opioid receptor partial agonist; methadone, Mu-opioid receptor full agonist; and naltrexone (ie. Vivitrol ®), Mu receptor partial agonist.

## How is MAT Used in Virginia?

- Virginia offers all three classes of FDA approved medications to treat opioid use disorder in adults and adolescents.
- Methadone can ONLY be prescribed in a licensed Opioid Treatment Program (OTP). OTPs are licensed by DBHDS, the Board of Pharmacy, and the Federal agencies, DEA and SAMHSA.
- Buprenorphine can be prescribed in an OTP, an OBAT (office-based addiction treatment) and by any prescriber who holds a DEA Registration.
- Virginia currently has 50 licensed OTPs: five are public programs (Alexandria, Norfolk, Hampton Newport News, Portsmouth, and Richmond Behavioral Health Authority, one is at a VA Hospital and 44 private for profit OTPs.
- All 40 CSBs offer referrals for medication assisted treatment either in house or through an MOU with a private provider.
- Office Based Addiction Treatment (OBAT) operate throughout the Commonwealth however DBHDS does not license or regulate OBATs.

## How is MAT Funded in Virginia?

- The federal State Opioid Response (SOR)has provided approximately \$8 million to CSBs for MAT.
- The SOR grant has also funded two mobile MAT/OBAT units.
- The FY 2024 General Fund appropriation for MAT is \$5,534,00.
- DBHDS provided \$500,000 to the private OTPs to assist the uninsured/underinsured Virginians struggling to remain in treatment.
- DBHDS has developed a program to support the use of MAT in the adolescent population, to provide training and consultation to work collaboratively with CSBs and other private providers.
