Town Hall meetings are searchable. The diagram below displays an example of searching for "All Past and Future" SIS-A meetings to locate the desired information. This search will display all meetings posted.

- 1. Clicking on the meeting name will open the electronic access for the meeting; the Zoom address will then be displayed.
- 2. Agenda will display the meeting agenda and slides.
- 3. *Minutes* will display the meeting minutes.
- 4. The links (*agenda* and *minutes*) will only appear once the information has been uploaded.

A total of 8 advisory group meetings and two informational meetings will take place—the initial informational meetings held separate meetings for individuals/families, providers, and support coordinators.
