June is Alzheimer's and Brain Awareness Month

Dementia in adults with intellectual and developmental disabilities will generally be the result of Alzheimer's disease, but they may also have dementia due to other causes.

Early signs may include changes in health, with the possibly of developing later-age seizures. Other changes may include the loss of skills for dressing, self-care, and completing multiple-step tasks. Loss of language skills and memory are other signs that changes may be connected to dementia.

Speak to the individual's primary care provider (PCP) about any changes in condition which might be dementia related.

ABA Snippets ...

Cultural Responsiveness

A behavior support plan includes many elements. An often-overlooked element is cultural considerations for the person, but this should not be the case. B.F. Skinner's (3) text, *Science and Human Behavior* makes many references culture, including the impact culture has on "the Scientist and individual" (p.41), culturally specific ways of laughing, cries of pain (p.161), and how we understand "friendliness" or "aggressiveness" (p. 302).

Jimenez-Gomez and Beaulieu (2) expand upon the importance of cultural considerations, "The learning histories of members of the community shape what are considered conforming behaviors and hence, profoundly impact a range of behaviors including communication, social behavior, daily routines, traditions, values, and beliefs. Thus, to deliver socially meaningful behavior-analytic services, the role of culture must be considered at every step of behavior-analytic services and research [italics added for emphasis]" (pp. 650-651).

They continue, "Cultural responsiveness avoids gross generalizations (e.g., stereotypes) and stresses the importance of focusing on the individual and the distinct intersecting cultural variables impacting the individual's behavior. This term also highlights the importance of identifying aspects of the environment (i.e., cultural variables) that impact the behavior and effective care. Further, cultural responsiveness embodies relationship building and working collaboratively with clients to achieve effective and meaningful outcomes" (2, p. 651).

The importance of cultural considerations and responsiveness cannot be overemphasized. In addition to being part of the DBHDS/DMAS Practice Guidelines for Behavior Support Plans (5), culture is stressed in both the BACB (code 1.07, 1) and PBSF (code E.5.b., 4) ethics codes. Beyond ethical or regulatory requirements, we know that the environment must be examined to understand behavior, and this includes examination of, and considerations related to culture.
