Tips & Reminders

- 1. Be sure to spell your Location Information correctly to mitigate possible duplicate locations in the system.
- 2. To relocate a service, you will need to submit an Information Modification to Close a Location as well as a Location Modification to Add a Location.
- 3. Location Property Owners and Staff Resumes are optional.
- 4. Remember to Sign and Submit all modifications in CONNECT. If the status is "Pending Submission," then it has not been submitted to DBHDS and will not be processed.



CONNECT Adding Locations



- 1. <u>All</u> Location Modifications must include:
 - 1. Notification of Address and Proposed Opening Date
 - 2. Staffing Pattern, Staff Credentials
 - 3. Working Budget and Proof of 90-Day Financial Capacity
- 2. <u>Residential</u> and <u>Center-Based Services</u> must include:
 - 1. Certificate of Occupancy
 - 2. Current Health Inspection (*'if not applicable you can upload a* **Word Doc**. Stating as *much*)
 - 3. A Floor Plan with Dimensions
- 3. <u>Residential Only</u> must include:
 - 1. Name and Number of Community Liaison
 - 2. Current Fire Inspection (*if not applicable, you can upload a Word Doc. stating as much)
