


Happy Holidays



The New Year is a Great Time to Schedule an Annual Physical or Wellness Exam!

Adult Medicaid members receive coverage for preventive services. Preventive services are defined as routine health care that includes screenings, check-ups, and patient counseling to prevent illnesses, disease, or other health problems.

Preventive services can help people improve their overall health before something becomes a larger problem.

This coverage is provided by DMAS for all adult Medicaid members as a proactive step to help improve overall health to all members.

The following preventive services are available at no cost to Medicaid members:

- Adult wellness exam.
- Individual and group smoking cessation and alcohol counseling.
- Recommended vaccines, such as tetanus and diphtheria, shingles, hepatitis A and B, influenza, and human papillomavirus.
- Mammography, prostate, and other cancer screenings.
- Blood pressure and cholesterol screenings.
- Depression screenings.
- Nutritional Counseling.

Medicaid members should contact their primary care doctor to schedule one of these preventive services.

ABA Snippets ...

You Have the Right to....

Have you ever thought about what your human rights are? I'm not talking about constitutional rights. I'm talking about fundamental human rights. Many people have heard of the term "Human Rights," but are not aware that there is actually a Declaration of Human Rights that was developed by the United Nations back in 1948 (you can read it here <u>https://www.un.org/en/about-us/universal-declaration-of-human-rights</u>). This Declaration of Human Rights pertains to all humans. In the Commonwealth of Virginia, there are additional regulations related to human rights for those served by providers that are licensed, funded and operated by DBHDS (you can read those here

https://law.lis.virginia.gov/admincode/title12/agency35/chapter115/).

So why am I talking about human rights in a column about applied behavior analysis? Because if you are reading this, there's a very good chance you work with individuals with disabilities, in some form or another. When writing, implementing or reviewing behavior interventions, it is important to ensure those interventions do not restrict the rights of the individual, without proper justification. How do you know if the intervention is restricting a right? Ask yourself "could someone do this to me?" and check the Virginia Human Rights Regulations. If it is determined that the intervention is restricting a right, then follow the Virginia Administrative Code 12VA35-115-100, which states "Providers shall not impose any restriction on an individual unless the restriction is justified and carried out according to this chapter or otherwise required by law." A good rule of thumb for deciding if a restriction is justified is: if there is a health and safety concern and less restrictive measures have not been successful in maintaining health and safety.
